### I. General Business

- Meeting called to order at 1:05 after quorum was reached

## II. Middle States Periodic Review - Sophia Howlett

- Repeat presentation a consequence of requests from new members
- Timeline: between self-studies
- MSCHE standards have changed but Kean is among the last group of institutions to be judged under the previous standards
- Not a mini-self-study (50 page report) but to gauge progress and help MSCHE to judge progress. Key elements of periodic report:
  - 1. Changes, developments or challenges since the self-study
  - 2. Kean's response to previous recommendations and monitoring reports. No need to re-answer; rather, just indicate completed or not referencing earlier reports. Only outstanding recommendation reducing the number of GE SLOs (completed). Curriculum being

- reorganized way ahead of the report. Need to show that "closing the loop" has sustainability.
- 3. Institution's enrollment trends and financial outlook
- 4. Current status
- 5. Show how institutional planning is linked to financial planning and resource allocation
- Work on the periodic review is in early stages, but we are in good shape. Need to include developments in General Education, the new Strategic Plan, reorganization which now includes enrollment management, new programs (DPT, PA, etc.), online learning, new support mechanisms for transfer student.
- Focus on Standards 7 & 14, and Standard 2
- III. Preparation for November 10 meeting for "closing the loop" and prioritizing division requests
  - Members will have access to all division reports and allocation requests to review prior to the meeting (Susan DeMatteo has already shared the documents with members on Google Drive); at the meeting we will have opportunity for discussion; will use clicker technology for anonymous responses
  - This is not a competitive process; our role is to evaluate the level of priority for each request and make recommendations to the President
  - Because the UPC has broad representation in its membership, questions about requests can be answered
  - The meeting has taken under two hours assuming all members review the requests.
  - A scale will be created for voting to assist us in assigning priorities
  - Member attendance at the meeting is essential since presence during discussion is important
