

## Kean University Request for NJ Dream Act Exemption For Eligible New Jersey High School Graduates

## **Application and Affidavit**

The Dream Act, signed into NJ law, December 20, 2013, ensures an in-state tuition rate for all New Jersey residents, regardless of immigration status, if you meet criteria as listed below. Please complete <u>all</u> sections and sign to request <u>exemption</u> from out-of-state tuition and fees charged to non-New Jersey residents. If Kean University determines that you are eligible for in-state tuition, you will continue to receive the exemption as long as you fulfill the requirements or the University no longer offers this exemption, whichever occurs first. Applicants seeking the exemption are encouraged to complete the affidavit as soon as possible to avoid incurring additional charges.\*
