The mean for this SLO in 2013 overall is low, 2.86 (N=96), and less than in previous years. The mean from FA/11-SP/14 is 2.986.	The analysis of the data over the period from FA/11-SP/13 reveals that native Kean students score higher than transfer students in this area. A common factor is the transfer of law related courses from 2-year colleges as an equivalent of the major core course. Recommendations include reassessing transfer equivalencies, and requiring all students to complete law related courses as a part of the core requirement at Kean.

This area reveals the lowest level in terms in mean scores, 2.06 in SP13. This is an improvement over the mean from FA/11-SP/14, which is 1.98.	The proficiency of students in this area is far below acceptable levels associated with general knowledge. A common factor is the transfer of criminology related courses from 2-year colleges as an equivalent of the major core course. Recommendations include re-assessing transfer equivalencies, and requiring all students to complete la related courses as a part of the core requirement at Kean. Assessment will be shifted to a major core course, Juvenile Justice, and will focus on theory and causation.

This area demonstrates increased student knowledge with a mean of 3.46. This is an improvement over the mean from FA/11-SP/14, which is 3.25.	This is one 3 areas that students must complete course work at Kean, transfer equivalents do not apply. This course is intensive, hands-on, with increased student-faculty interaction. Specific areas in need of improvement include student writing, the impact of student research, and demonstrating evidence of methodological issues. Recommendations include; adding a 1-credit lab component to the course that emphasizes student writing; limit the vast number of topics to more timely and relevant criminal justice topics in an effort of reducing the saturation of specific topics commonly used by students over the course of time; and strengthen the students' knowledge and use of relevant statistical models used in social science research.

(Skilled or completely done).	semester, with students averaging a mean of 2.659 in the established range (0-3) when submitting the final written assignment. The recommendation of adding a 1-credit lab to this course is expected to improve overall communication skills.
